OPRY disputed the pace to the first turn then lead way into the backstretch, continued on top with a length advantage and held firm still unleashed along inside around the far turn, roused for more entering the lane, stayed sharp in response under steady pressure, continued to turn back bids through the lane and kept clear. BOURBON IN MAY was unhurried in opening stages and continued in the back along the outside down the backstretch, picked up the pace entering the far turn, swung into action entering top stretch and rallied up to gain the runner up spot. ROAD TO MEATH disputed the pace going by the wire for the first time then edged back and stalked the leader down the backstretch, launched a two wide bid for command around the far turn, advanced to race in striking distance a furlong out but lacked the needed surge to get by. COUNTER OFFER secured inside position around the first turn, stalked along the rail to the far turn, hustled up along the inside then switched out top of the lane, advanced to race in striking range a furlong out then yielded in late stages. SURF AND TURF was a step awkward and came away last at the start the angled in and saved ground on first turn, settled off the early pace the picked up the pace along the inside on the far turn, gained ground upper stretch but failed to sustain and flattened out. MOTATAABEQ raced in range and tracked the pace down the backstretch, launched a three wide bid near the quarter then gave way in the lane.
